Manual del usuario

Open Journal Systems (OJS) es una plataforma para la circulación de textos en el proceso editorial y un sistema para una publicación en línea.

Gracias a la integración, los usuarios de ambos sistemas pueden:

- operar los sistemas integrados a través de una única cuenta en OJS;
- enviar documentos para su análisis antiplagio con un solo clic;
- recibir el informe de similitud en la cuenta del usuario en OJS.

Antes de utilizar el plugin, debe crear el envío y cargar el archivo.

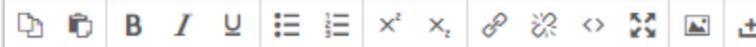
